Heath Hands is a charitable incorporated organisation, governed by its Trustees, all of whom are appointed by members in General Meetings. The Trustees herewith submit their Annual Report and independently examined financial statement for the year ended 31st March 2018. The Trustees employ staff to administer the charity. Membership is open to registered volunteers who contribute to our charitable activities.

Trustee Responsibilities

The Trustees are responsible for preparing the Annual Report and financial statement in accordance with applicable United Kingdom charity law. The trustees have given consideration to the major risks to which the charity is exposed and satisfied themselves that appropriate procedures are in place to manage those risks

Objects

To help, engaging volunteers, to conserve, protect and enhance Hampstead Heath, the Kenwood Estate, Highgate Wood, Keats House and such other areas as the charity trustees may determine from time to time (the "Relevant Open Spaces");

To advance education in conserving, protecting and enhancing the environment of the Relevant Open Spaces for the benefit of the members of the CIO and for the benefit of the public at large, and

To help the bodies responsible for the Relevant Open Spaces to provide facilities in the interests of social welfare for recreation and leisure time occupation by the members of the CIO and the public at large with the object of improving their conditions of life.

Cindy Galvin (CG) welcomed attendees including our guest speaker Matthew Maran, Declan Gallagher and Richard Gentry (CoL). Special welcome to Karin Oleinikova who joined as Project Assistant in July.

Apologies received Karina Dostalova, Chairman of the Management Committee and Trustee, Tony Ghilchick, Lesley Lander, and Daniel Braverman.

Minutes of the 2016 AGM

Minutes reviewed. There being no matters arising, acceptance proposed by Ian Greenwood, seconded by Angela Durkin.

Mathew Maran: photography and Hampstead Heath

Mathew thanked Heath Hands and CoL for his invitation. He shared his passion for the Heath, and shared some of his techniques and excellent photographs, explaining about the locations and stories involved. He outlined the process of publishing the Hampstead Heath book and his pleasure in collaborating with Heath Hands and CoL on the 2018 Nature Calendar.

CG thanked Matt for his presentation, and attendees showed their appreciation.

Annual Report 2016/17

CG presented a review of a significant year in the charity's history. Special mention for Dan, sadly stepping down as Chairman, he made an incredible contribution during his short tenure.

This year we formalised our relationship with City of London by agreeing a Partnership Agreement including secondment arrangements for the Projects and Volunteer Manager. We published our Strategic Plan through to 2020 to support the development of our organisation and our various volunteering programmes. We began the process to become a Charitable Incorporated Organisation. This is the last AGM of the previous Heath Hands, next year's will be the first for the CIO. The SGM in the Spring secured approval for the transition.

We reached the milestone of 100,000 hours of volunteering across our green spaces – an achievement marked with celebrations at Kenwood last Autumn. Cindy shared her pride in these accomplishments and thanked everyone involved. Our membership reached record levels, and we surpassed 11,000 hours of volunteering. Our Wildlife Interpreters engaged thousands of visitors through Wild about Hampstead Heath. We launched volunteer led sessions at Whitestone Garden and the Old Orchard Garden and Phoenix Futures began weekly programme of Recovery through Nature sessions. Our programme of walks and talks on everything from geology to amphibians has been well attended and social events and visits to neighbouring green spaces – Epping Forest and Burnham Beeches enjoyed by many.

Finally, we secured grant funding to deliver the Community Heath outreach project, which launched in July. CG delighted to announce that a second grant was secured this month to expand the project further.

CG gave thanks on behalf of the Trustees to the team at Keats for hosting us tonight, Matt for his excellent presentation and Dan for his contribution as Chairman, noting he will be missed.

A few farewells, as Virginia Rounding stepped down as Chairman of the Management Committee (and as a Trustee), Phil Wright who stepped down as General Manager of Kenwood (and as a Trustee), Paul Jackson who retired as Head Gardener of Kenwood and Saba Rokni who is stepping down as a Trustee.

CG thanked Bob Warnock, the Superintendent and his management team for their continued support our partners at English Heritage who welcomed a new General Manager. Also thanks to the Kenwood Garden Team led by Dave Gibbons, Golders Hill Park and Hill Garden team, Highgate Wood and Parliament Hill teams, The Heath's Conservation and Ranger teams and Meg Game and Adrian Brooker the ecologists who oversee our Wildlife Monitoring programme. Finally a special mention to Caroline Turner who stepped down as Head Gardener of the Hill Garden after many years.

Cindy closed by remarking how proud our founder Bobby would be at this time.

Treasurer's Report

Peter Gilmour thanked our Independent Examiner, Tony Ghilchick and his predecessor Tony Grimes. Peter presented the Annual Accounts noting the ample funds available, notably from our founder's legacy. The trustees agreed a Reserves Policy this year, planning to spend £19,500 over the next three years on projects to benefit our green spaces. Donations were gratefully received from the Kenwood Walking Ladies and Park Hill School.

CG thanked Peter.

Any Other Business


Tony Grimes asked about Community Heath, and whether the Wild about Hampstead Heath project was set up to encourage new groups onto the Heath. Tony also enquired about the projects evaluation report and what it showed.

Colin Houston responded that the part of WaHH that was handed over to Heath Hands engages existing users, Community Heath, takes on the community outreach aspects of WaHH focusing on engaging new audiences and those with additional support needs. The third aspect of the project involved schools, and this was taken over by the CoL Learning Team. Bob Warnock agreed that the WaHH evaluation report should be made available.

Liz Andrew asked about developing links with the London Natural History Society and our Wildlife Monitoring programme. Colin reported that discussions are ongoing around how best to coordinate the various programmes related to ecology.

Bob Warnock thanked everyone for their involvement over the last year, it is an exciting time and the breadth of activity is incredible such as here at Keats which is so well maintained. He thanked the Trustees, who are themselves volunteers, our employees Karin and Colin. He thanked members for their comments on the Heath Vision, there will shortly be a ten year strategic plan published, alongside a three year management plan.

CG closed the meeting at 18.50.








Fig 3. Volunteers from BAME (Black, Asian and minority ethnic communities) and White backgrounds (target 36% BAME)




Fig 2. Membership Activity





Fig 4. Age Structure of active volunteers (%)












Fig 6. Volunteer sessions delivered: 532 (blue) versus 3 year average






Fig 8. Community200Heath: events140and participants;140target of 800100participants60

Policy for Legacy and other Reserve Funds

Background

In 2009 our founder, Bobby de Joia left £50,000 in her will to Heath Hands, with no restrictions. Most of this is unused. With other funds, financial reserves at 31 December 2016 were approximately £70,000, held in two deposit accounts with Scottish Widows and Charities Aid Foundation (CAF) Bank. The most appropriate use of the funds was discussed at Trustee meetings on 16 November 2016 and 11 January 2017, and it was agreed to develop this Reserves Policy.

Discussion

The debate was between keeping 'rainy day' money against potential future risks, and using it soon to enhance the Heath. Both were accepted as valid uses. Trustees felt that some of Bobby's legacy should be used for specific identifiable projects.

Potential risks were identified as the withdrawal of the substantial benefits in kind provided to us by English Heritage (the lease of the Dairy) and the Corporation of London (CoL) (secondment of the Projects and Volunteer Manager (PVM)). Both of these arrangements expire in 2020.

Trustees favoured a prudent approach, that is, to retain a fairly large reserve against risk; but to use the remainder over the next three years, through to 31 March 2020, the period covered by our Strategic Plan.

Heath Hands will keep enough reserves to cover running costs for three years, and a sum of £35,000 against the risk of losing the above benefits in kind.

Conclusion

Heath Hands will hold £15,000 as 3 years running costs, and £35,000 against risks specified above, with the remainder intended to be used for identified projects meeting Heath Hands' objectives by 31 March 2020. This policy will be reflected in the Strategic Plan.
